*SEE THE SOUNDS seeks to bring new visualizations to a variety of songs. Artists are encouraged to choose a lyrically-based song and create a piece of visual art around it. We want to see imagery that brings to light the feelings and reactions the artist has when listening to the song. Song lyrics will be on display alongside the visual piece.*

### SUBMISSION RULES

This show is open to residents of Minnesota. 2d or 3d work eligible for this show. Artwork must not have been previously exhibited with TCAA. All work must be ready to install. No artwork shall violate any copyright. All artwork will remain in the gallery for the duration of the exhibit. Submission fee is \$10 for Crossing Arts members and \$15 for non-members and is non-refundable. Artists may submit up to 3 pieces for consideration for the \$10 or \$15 fee.

### DELIVERY

**Hand delivery** – work may be delivered to The Crossing Arts Alliance. For those who must use shipping – each artist is responsible for all shipping costs to and from the gallery. Shipped art should arrive at The Crossing Arts Gallery no later than December 28, 2017. Any special opening and hanging instructions should be accessible on the exterior of the container. Return shipping is the responsibility of the artist. Pre-paid return shipping labels should be included with the package. They can be attached in an envelope on the exterior of the package. Please allow two weeks for return shipping after the end of the exhibition. Gallery is not responsible for works not collected after the pickup dates or without return prepaid shipping information. After 30 days of storage, works will become the property of The Crossing Arts Gallery. Avoid shipping works framed under glass.

### LIABILITY

Every effort will be made to ensure the safety of exhibited works. Artists are encouraged to insure their pieces and must agree to hold The Crossing Arts Alliance harmless for any damage that may occur. The Crossing Arts Alliance, its agents and employees, assume no responsibility for the safety of the works submitted or exhibited. Shipping insurance to and from the gallery will be the responsibility of the artist.

### SALES

The Crossing Arts Gallery will retain a 30% gallery commission of the listed price on all work sold. Work may be listed as "Not For Sale" (NFS)

### CONDITIONS

Your submission grants the following: 1) Permission to The Crossing Arts Alliance to use digital images sent by the artist for publicity/promotional and/or educational purposes. 2) Placement of digital images on our website unless written notification is given to The Crossing Arts Gallery before exhibit opening. 3) Agrees with all the terms and conditions listed above. 4) Releases The Crossing Arts Alliance of any loss or damage of works.

### HOW TO SUBMIT

First, you will be asked to pay the submission fee via the TCAA online shop (link on [crossingarts.org](http://crossingarts.org)), in-person at TCAA office, or by mail at 1001 Kingwood St, Suite 114, Brainerd MN 56401, then email your images to [submissions@crossingarts.org](mailto:submissions@crossingarts.org) along with a scanned copy of your completed submission form. **PLEASE DO NOT DROP OFF WORK TO BE JURIED.** Provide the following information for each image: title, medium, date produced, size, and price. Submission received without complete information and payment will not be considered. A confirmation email will let you know that we have received your images.
