Art to Wear - Textiles and Beyond seeks to discover and showcase interesting wearable art. This show prioritizes creativity over practicality, but entries must be wearable for the runway show. Media is not limited to textiles.

SUBMISSION RULES

Artwork must have been created in the past two years and not previously exhibited with TCAA. Artists will provide their own models for the runway show. Artwork selected from the runway show will be exhibited in The Crossing Arts Gallery for the duration of the exhibit. No artwork shall violate any copyright. Submission fee is \$10 for Crossing Arts members and \$15 for non-members and is non-refundable. Up to 3 pieces may be submitted for consideration.

PICK UP OR RETURN

Work must be picked up October 3-6. Return shipping is the responsibility of the artist. Pre-paid return shipping labels should be included with the packaging. They can be attached in an envelope on the exterior of the package. Please allow two weeks for return shipping after the end of the exhibition. Gallery is not responsible for works not collected after the pickup dates or without return prepaid shipping supplies. After 30 days of storage, works will become the property of The Crossing Arts Gallery.

LIABILITY

Every effort will be made to ensure the safety of exhibited works. Artists are encouraged to insure their pieces and must agree to hold The Crossing Arts Alliance harmless for any damage that may occur. The Crossing Arts Alliance, its agents and employees, assume no responsibility for the safety of the works submitted or exhibited. Shipping insurance to and from the gallery will be the responsibility of the artist.

SALES

The Crossing Arts Gallery will retain a 30% gallery commission of the listed price on all work sold. Work may be listed as "Not For Sale" (NFS)

AWARDS

A People's Choice Award will be given. Winner will be featured in TCAA's quarterly newsletter, The Crossing Currents.

CONDITIONS

Your submission grants the following: 1) Permission to The Crossing Arts Alliance to use digital images sent by the artist for publicity/promotional and/or educational purposes. 2) Placement of digital images on our website unless written notification is given to The Crossing Arts Gallery before exhibit opening. 3) Agrees with all the terms and conditions listed above. 4) Releases The Crossing Arts Alliance of any loss or damage of works.

HOW TO SUBMIT

First, you will be asked to pay the submission fee via crossingarts.org, in-person at TCAA office, or by mail at 1001 Kingwood St, Suite 114, Brainerd MN 56401, then email your images, front and back for each entry, to submissions@crossingarts.org along with a scanned copy of your completed submission form. **PLEASE DO NOT DROP OFF WORK TO BE JURIED.** Provide the following information for each image: title, medium, date produced, size, and price. Submission received without complete information and payment will not be considered. A confirmation email will let you know that we have received your images.
