The trip included a couple of days at the trade show

While the Trade Show was in the capital city of Dhaka, the Saskatchewan delegation also travelled to Chittagong City where STEP and the High Commission presented a seminar to local commodity buyers. Chittagong is port city and receives the bulk of Bangladesh imports. It is clear those business people are very familiar with Saskatchewan wheat and pulse crops and are big fans of our products.

“The trip was a real adventure for me in terms of learning about the Bangladesh culture and also more of the export market system in which Saskatchewan does so well. It was also a reinforcement of the belief we have held in the great work STEP does in global trade and it's largely due to their expertise Saskatchewan has such a huge export sector. Jennifer Evancio worked tirelessly before, during and after this trip setting up meetings, coordinating activities and ensuing follow-ups were done in the proper manner “said McLellan.

Legislative Report

Saskatchewan Government to consult on renewal of labour legislation

The Government of Saskatchewan is proposing to modernize, simplify and amalgamate labour legislation as well as explore the creation of a Saskatchewan Employment Code.

The intent of the review is to: (1) restructure and re-organize the legislation so it is easier to use and understand; (2) eliminate inconsistencies to reduce confusion; and (3) clarify which legislation applies in particular situations. Some examples of the topics under consideration are: essential services legislation, union financial disclosure, notice requirements, collection of employees' wages after business closure, variable hours of work to meet needs of both employers and employees, and indexation of the minimum wage. 2011 GDP growth highest in almost 15 years

Saskatchewan's economic growth in 2011 was its fastest in almost 15 years according to data released today by Statistics Canada. Saskatchewan's GDP grew by 4.8 per cent, second highest in the nation and the best performance since the starting year of this statistic in 1997. Alberta led economic growth in 2011 with an increase of 5.2 per cent.

According to the report, Canada's GDP rose by 2.6 per cent in 2011. The report referenced Saskatchewan's improvement was based on better than expected crop production, high residential construction, and gains in wholesale and retail trade. It also suggests that strong population growth contributed to the overall rise.

February retail sales hit record numbers

Saskatchewan's retail sales took a jump in February with a 6.2 per cent increase in February 2012 over February 2011 totalling \$1.38 billion, the highest ever for the month. Saskatchewan had the third highest percentage increase in Canada over this period.

Retail sales rose by 0.7 per cent in February 2012 when compared to January 2012. Saskatchewan had the highest percentage increase in Canada during this period. Nationally, sales dropped by 0.2 per cent.

Saskatchewan employers offer 280 positions to skilled workers from Ireland

Saskatchewan employers have offered more than 280 positions to skilled workers as a result of the March 2012 mission to Ireland. This means that the goal of this recruitment mission has already surpassed its objective of 275 jobs being offered.

The delegation, which included 27 Saskatchewan employers, took part in recruitment fairs in Dublin and Cork. The employer-driven mission included both Premier Brad Wall and Advanced Education, Employment and Immigration Minister Rob Norris. The Government of Saskatchewan provided on-the-ground advice to Saskatchewan employers and assistance to potential candidates.

"The response from Ireland was both positive and sobering," Norris said. "While thousands of people in Ireland continue to look for opportunities in Canada and elsewhere, we are pleased to be able to invite more than 280 of the skilled applicants to come and discover the Saskatchewan Advantage."

Record wholesale trade statistics in February

February was a record-setting month for wholesale trade in Saskatchewan according to a report released by Statistics Canada today.

“This record-setting month for wholesale trade is a good indicator that our economy is growing, and that both businesses and families are feeling confident,” Enterprise Minister Jeremy Harrison said. “Businesses and consumers are in purchase mode and wholesalers are stocking up to meet the greater demand for goods.”

Between January 2012 and February 2012, wholesale trade was up 6.0 per cent, the second highest among the provinces. Saskatchewan had the third highest percentage increase in the nation on an annual basis, as trade rose by 11.7 per cent in February 2012 over February 2011.

Saskatchewan’s economy shows its strength as EI numbers drop

Saskatchewan’s economy continues to show its underlying strength as the number of people receiving Employment Insurance (EI) decreased to 9,610, a 13.7 per cent drop, in February 2012 compared to the same month in 2011.

“With 23 months of year-over-year decreases in the number of people receiving EI benefits, our economy is showing its solid foundation,” Advanced Education, Employment and Immigration Minister Rob Norris said. “Average weekly earnings are rising and job opportunities are plentiful. This combination of factors builds even greater confidence in employers and investors.”

Saskatchewan experienced a 3.8 per cent decline in regular EI beneficiaries compared to January 2012 which ranks as the second highest decline among provinces.

The trend of fewer EI beneficiaries also continues in both Saskatoon and Regina. Saskatoon posted a year-over-year decrease of 14.8 per cent and Regina dropped by 17.1 per cent.

Saskatchewan had the second lowest number of regular EI beneficiaries as a percentage of the labour force population (1.2 per cent) behind Alberta at 0.9 per cent, and below the national average of 2.0 per cent.

INSIGHTS TO TOMORROW

PART THREE: FINDING NEW WAYS TO DIG A HOLE

In last month's column, I talked about the world of opportunities opening up in the municipal infrastructure sector. With the global spending on infrastructure expected to run into the range of \$1 trillion, a lot of money is up for grabs for innovative businesses with the vision to go after it.

But businesses aren't the only ones who stand to benefit from the infrastructure revolution. This period of renewal also challenges municipalities to rethink their old ways of doing things and come up with new and better ways.

An example of this is Communities of Tomorrow's Service Connector. From time to time, we host brainstorming sessions with municipalities to identify their top challenges. At one session, repairing and replacing municipal water service connections emerged as the top issue.

If you are a homeowner you can appreciate the importance of this issue. You've probably seen – or, worse luck, experienced – what happens when a city crew has to dig up a homeowner's front lawn to get at a water shut-off valve.

Communities of Tomorrow created the End-to-End Service Connection Design project. To work on solutions to the issue, engineering and public works staff from seven cities joined with business experts as well as researchers from the National Research Council, University of Regina, SIAST and the Saskatchewan Research Council.

The pilot project's initial tests this past winter have been successful. From here, we are looking forward to developing even more exciting cutting edge technology including the use of robotics to achieve trenchless removal of water and sewer lines.

If the technology is successful, CT will look for western Canadian firms to manufacture the product and, potentially, to provide service connection replacement services for communities that can't afford to buy the equipment.

Once perfected, the technology could save cities significantly on the current cost of service connection replacement, which could result in millions of dollars in savings for Saskatchewan municipal taxpayers on existing service connections. The system has the potential to be commercialized right here in Saskatchewan for the world market.

The system has the potential to be commercialized right here in Saskatchewan for the world market.

Service Connector is one of the best examples of Communities of Tomorrow's "innovation hub" business model. By bringing together municipalities, researchers and entrepreneurs, we create win-win-win situations that generate business opportunities, new technology and stronger cities for everyone in the province.
