The Chamber's legislative agenda is a comprehensive approach to creating a competitive business climate and investing in the future of the Commonwealth. "Clearly, our agenda is a full one, and we know that additional issues will emerge as the session progress," said Adkisson. "As always, we look forward to the opportunity to represent the interests of Kentucky's employers as we work together to build a stronger future for our Commonwealth."

The event concluded with Adkisson and the Kentucky Chamber giving State Representative Leslie Combs the MVP Award for going to "bat" for business. Combs received a commemorative Louisville Slugger Bat from the Kentucky Chamber.

On December 2, the Chamber hosted Eggs and Issues. This event is dedicated to education and networking. The December Eggs and Issues was presented by US Bank and Small Business Sponsor, The Law Offices of Johnson Crump. The morning featured Dave Adkisson, President/CEO of the Kentucky Chamber, Brad McLean, Director of External Affair for AT&T-Kentucky, and an award presentation to State Representative Leslie Combs.

Brad McLean presented on the issue of telecom reform in Kentucky. McLean and the team at AT&T Kentucky are working to reform Kentucky's telecommunications laws to spur investment in high-speed telecommunications infrastructure that supports business and commerce.

Kentucky Chamber President and CEO Dave Adkisson outlined the Kentucky business community's goals for the 2015 General Assembly and discussed the Kentucky Chamber's 2015 Legislative Agenda, which places special emphasis on the need for public-private partnership (P3) legislation and financial transparency in Kentucky's pension systems.

The visit to Pikeville is part of a 12-city tour across the state aimed at familiarizing members of local chambers of commerce with the priorities of the Kentucky Chamber.

"As we head into the 2015 General 4 | **BUSINESS CALL** 

Assembly, there are a number of issues that could have a significant impact on the health of the business community," said Adkisson. "Our goal with this tour is to ensure our members and local chamber members are not only educated on those issues, but stay looped in as those issues continue to evolve during the session."

Adkisson says several legislative issues which the Chamber advocated heavily for in the 2014 session are still on the table as we move into the 2015 session.

"We were disappointed by the amendment that led to the Governor's veto of P3 legislation at the end of the 2014 session," said Adkisson. "This year, we will continue to push for passage of a comprehensive plan that will encourage the creation of partnerships between private companies and government to create jobs, while saving tax dollars and providing needed projects and services."

As for the state's pension system, Adkisson says the "day of reckoning has come."

"Our bond rating has already been downgraded three times. Kentucky's one of the worst states, frankly, among all 50 in terms of our total liabilities. So we have to continue to address our pension issue." He added, "Some major reforms have been made in 2008 and 2013, but we've got to keep our eye on the ball because it's going to require a sustained commitment

### **PLI Hosts Session on Education**

The Patton Leadership Institute met for their second of nine monthly sessions on Thursday, November 13. The focus of the session was on education. The day featured discussion with local education leaders including representatives from Big Sandy Community Technical College, University of Pikeville, The Holler, and the Pike, Floyd, Johnson, and Pikeville Independent school systems.

The session was held at University of Pikeville's Coleman College of Business and began with Josh Ball, Director of College Relations for BSCTC, discussing workforce development and the strides Big Sandy is making to prepare their students to become skilled and ready to enter the workforce upon graduation. Then Jacob Colley, Interim President/CEO of the SEK Chamber, conducted personal branding workshop.

The class had a panel discussion with four regional superintendents including Dr. Henry Webb of Floyd County Schools, Thomas Salyer of Johnson County Schools, David Lester of Pike County Schools, and Jerry Green of Pikeville Independent Schools. The superintendents touched on the efforts each of their respective school systems are making to ensure their students are becoming fully college or career ready.

The President of the University of Pikeville, Dr. James Hurley, also visited the class and discussed 21st century education and what the future looks like for the university. He also discussed his personal leadership and growth as president of UPIKE.

The class was then met by Dr. Steven Harris, Associate Dean of Academic Affairs for UPIKE and was given a tour of the Kentucky College of Osteopathic Medicine's Coal Building. The class toured training facilities including the Simulation Center, where students practice treating patients by using robotic patient simula-

tors, and Osteopathic Manipulation Therapy Lab, where students learn to diagnose, treat, and prevent illness or injury with their hands.

The day ended with a presentation by the Director of New Media for UPIKE, Bruce Parsons, about The Holler. Parsons introduced the class to The Holler and its progress in creating an open conversation of technology and learning in the Central Appalachian region.

Patton Leadership Institute began this year as a restructure of the Chamber's leadership program with an updated curriculum and mission. The program was named after Gov. Paul and Judi Patton to recognize their leadership and impact in not only our region but the entire state of Kentucky.
